

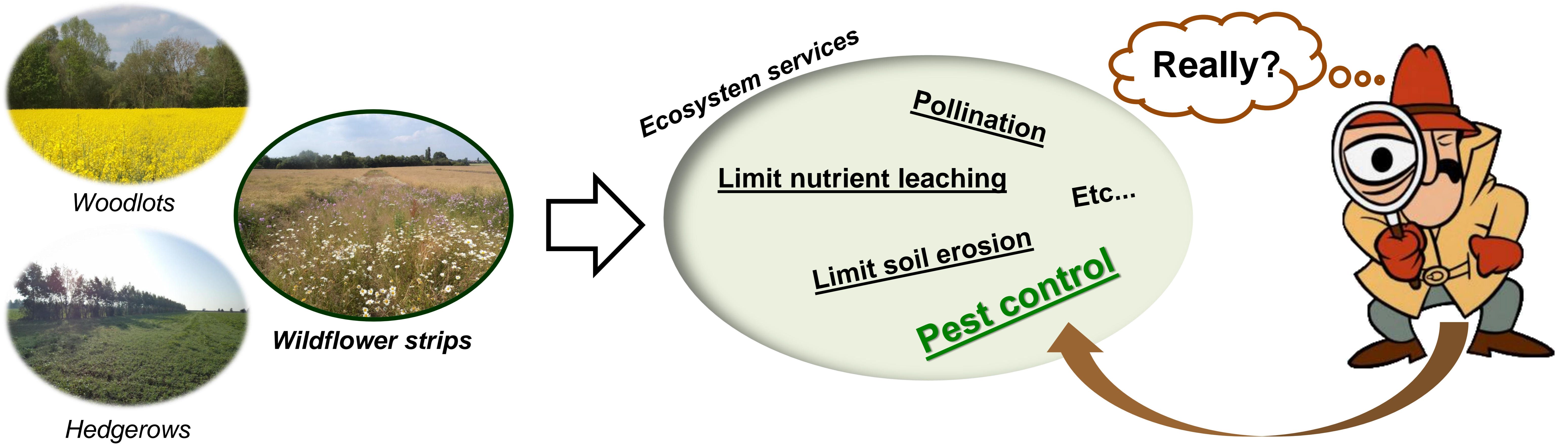

Landscape infrastructures are said to provide regulative ecosystem services¹

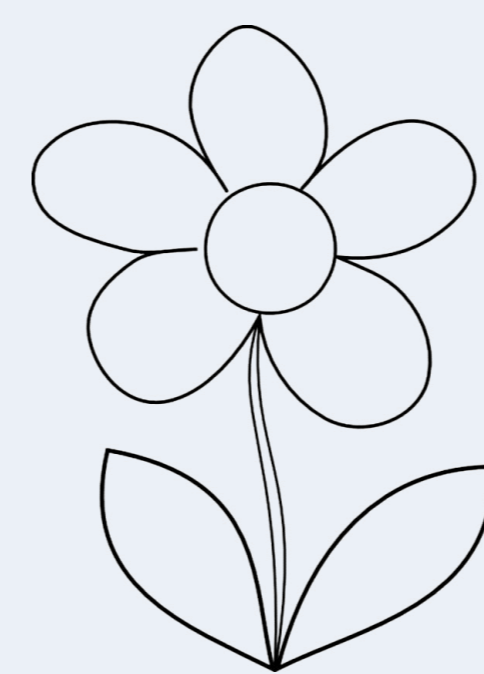


Wildflower strips do not necessarily favor pest control



Temporal incompatibility^{5,6}

- Between the pests and their natural enemies
- Between the natural enemies and the floral food resource availability



Food resource type incompatibility⁵

- Insect mouth pieces should be adapted to the flower corolla type
